






"...the design concept has been enriched by the intensely collaborative engagement and as a result, this collection challenges materiality and form in much the same way that I try to work within the architectural context."









Knoll designer, Sir David Adjaye, is a British-Ghanaian architect considered by many to be amongst the best in the world today. Adjaye was born in Tanzania to Ghanaian parents and his influences range from contemporary art, music and science to African art forms and the civic life of cities.


